

## PRIVACY STATEMENT FOR THE POLICE UNIVERSITY COLLEGE

The Police University College requires a registration in advance from all the participants to events, like lectures, seminars, conferences, social gatherings, etc. organised at the College. The personal data collected for registration will be processed following General Data Protection Regulation (2016/679) of the European Union. The data can be collected in person, by phone or mail, or by electric system provided by a third party and it will be used to control of the entry to the premises of the Police University College and the participation to the event in question.

Each participant registered to an event receives at the entrance a numbered visitor's badge and, when applies, an event specific badge. The badge(s) display right of access to the premises and attendance to the event requiring registration in advance.

### 3. Data subject

A person who wants to participate to an event at the Police University College.

### 4. Purpose of processing personal data

The personal data, that you are requested to provide for the registration, gives us the information needed for maintaining the safety and security of everyone in the premises of the Police University College. Moreover, it helps us to meet individual needs, for instance, in terms of access and dietary requirements.

### 5. Legal ground for processing personal data

Processing personal data is necessary for the purposes of the legitimate interests pursued by the controller (GDPR Art. 6, paragraph 1, point f).

### 6. Personal data we process

The personal data provided for the registration is handled by the personnel responsible for the event in question, the personnel controlling the access to the premises, and, when applies, as a list of names, by the canteen personnel at the cashier point.

### 7. Period of personal data retention

The personal data collected for the registration will be retained for three months at maximum from the date of the event in question. However, personal data, when required for the purposes of book keeping, are retained for six years.

### 8. Right to access to one's own personal data

You are entitled to inquire the Police University College about the processing of your personal data and receive an account of your personal data at the disposal of the College.

### 9. Right to rectification

You are entitled the right to request a rectification of your personal data. The rectification appeal must be submitted in writing and sent to the controller. It also possible to make the appeal in person at the Police University College.

## 10. Right to have your personal data deleted

You are entitled to request the Police University College to delete your personal data at its disposal.

## 11. Right to resist the processing of your personal data and request for limiting it

You are entitled to object the processing of your personal data and request to limit such processing until the issue of the Police University College's right to it has been resolved. However, when you have objected to the processing of your personal data and requested to limit the processing of it, you are not allowed to enter the premises and to participate the event organised there.

## 12. Right to refer matters to the Data Protection Ombudsman

If you feel, that the Police University College is processing your personal data in a way that is a breach of the law, you have the right to refer the matter to the Data Protection Ombudsman.
